**EMERGENCY ROAD CLOSURE NOTICE**

**FULMAR ROAD, PORTHCAWL**

**THE BRIDGEND COUNTY BOROUGH COUNCIL** hereby gives notice that under Section 14(2)(b) of the Road Traffic Regulation Act 1984, no person shall cause any vehicle to proceed in Fulmar Road, Porthcawl - From outside No. 86 to outside No. 90, a distance of approximately 30 metres.

The closure will be in force from the 17/02/2021 to 24/02/2021 or until such time as the works are completed for a maximum period of 21 days from the date of this notice.

The restriction is necessary in the interests of public safety due to insufficient width of carriageway to safely maintain vehicular traffic during emergency sewer repairs.

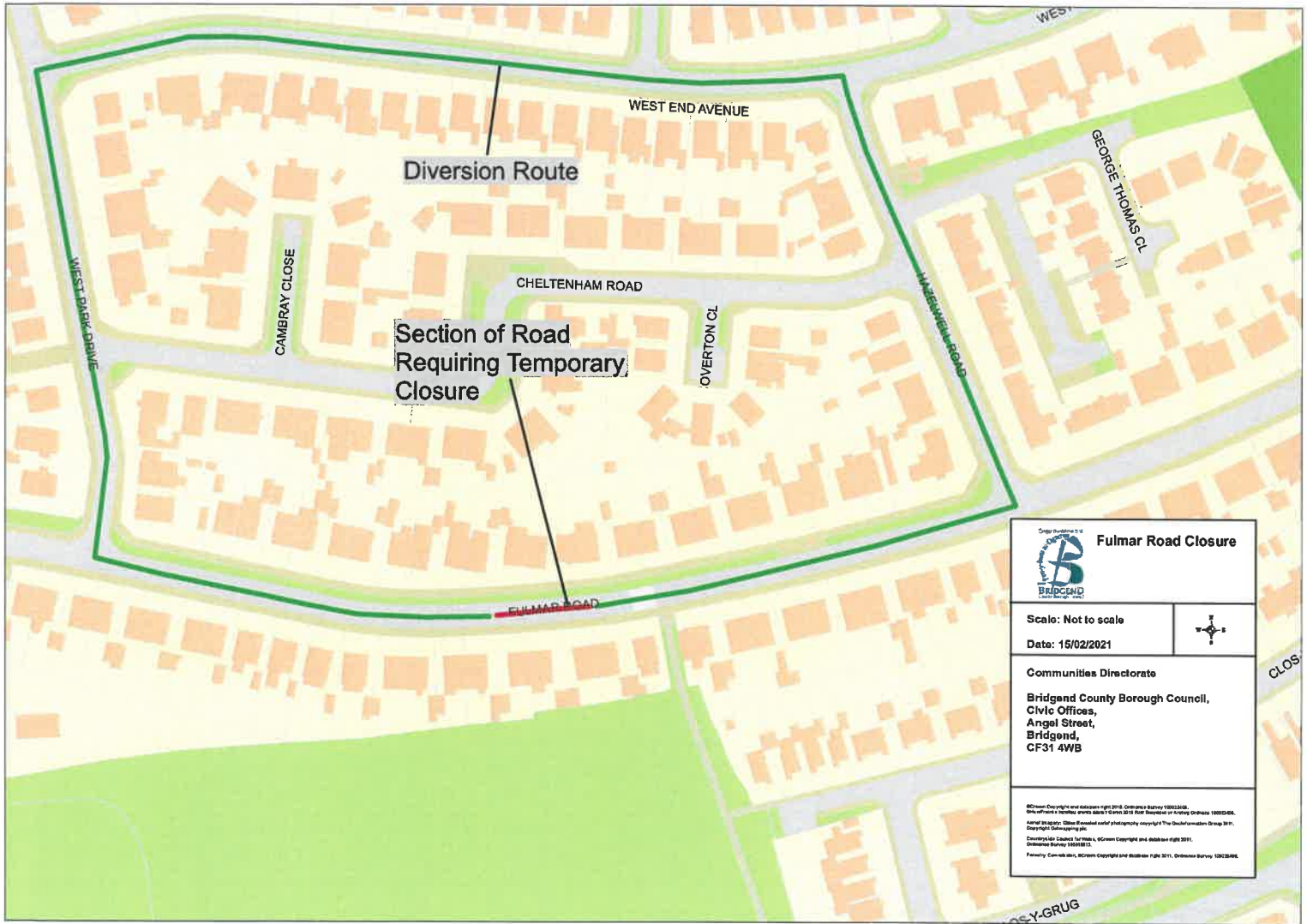
The restriction shall however only apply at such time and to such extent as shall be indicated by traffic signs prescribed by The Traffic Signs Regulations and General Directions 2016.

The alternative route is via: - Hazelwell Road, West End Avenue, West Park Drive and reverse in opposite direction.
